

Byrne Justice Assistance Grant Information by State

Each year, the Bureau of Justice Assistance makes a grant to each state in the form of the Edward Byrne Memorial Justice Assistance Grant. Portions of this grant are parceled out by the states to local agencies in support of specific initiatives highlighted by the state executives or legislature. These are often select program types deemed to be within the best interest of the state, such as an anti-drug taskforce or a community corrections initiative. The grants may require the grantee agency to match a portion of the award from their own funds to be put towards the specific program. When the individual state solicits and awards its grant money is based on factors such as its budget cycle.

The agency also has the opportunity to apply for the federal solicitation of the Byrne grant. It is believed that this solicitation will be posted in late April or in May, 2010. Much like the state grants, the federal solicitation has targeted funding priorities.

Sporadically, a state may issue a grant (either from their Byrne monies or from the general coffers) intent on providing funding for a specific program or service, such as a school resource officer initiative.
